Club Dues Update

As of the last Unpaid Dues Report, published by Kiwanis International on June 9th, fifteen (15) of our District Clubs owe more than \$150.00 in dues and/or fees. I realize that some may have paid since that date, but a significant number still have not paid and they are in danger of not having delegates seated at the International and/or District Conventions. Please be sure your club is current when you come to either convention. We have ballot issues to be considered at the delegate session and we need your vote at convention to handle the business of Kiwanis International and the Ohio District.

Report of Club Elections

The deadline for return of the Report of Club Elections form to Kiwanis International and the Ohio District was June 1, 2009. Once again all clubs using the KiwanisOne monthly reporting system should have reported their 2009-10 officer's online using KiwanisOne. As of June 12th, only 112 Ohio Kiwanis clubs have submitted their report through KiwanisOne. This means that a significant number of our 262 Kiwanis Clubs have not yet filed this report. If your club has not submitted the form, please do so immediately. This information is critical as it is used to publish the International and District directories. In addition, the information is also used to build a database that will be used for future mailings to your clubs. Thanks for your prompt attention to this request.

2009 District Installation

Please be sure and mark your calendar for the Installation of our 2009-10 District Board. The Installation will take place on September 19, 2009 in Dublin, Ohio and details will be coming to your Club Secretary in early August. We will also post information online using our district website at www.ohiokiwanis.org. The first official meeting of our 2009-10 Kiwanis Board will take place on Sunday, September 20th. We hope to see you in Dublin in September.

Make sure that your club sends its' two delegates for this very important election. For most Ohioans, it is only a 3 to 5 hour drive and it is a beautiful and historic town to visit.

Even with major budget cuts this year, the Ohio District could no longer postpone a dues increase. The annual \$8.00 or 67 cents monthly dues increase is the first since 1998. Some other districts have annual dues increases while most rarely go more than 3 or 4 years, while we have gone eleven years. The loss of over 4,000 members over the past eleven years, the drop of the stock market investments, and inflation over eleven years, leave us no choice to maintain quality service to our clubs and members.

The best way to avoid future dues increases and provide the vital service needed for our communities is through increased membership. Please help put a membership plan in place for your local club, help sponsor a new club to replace the missing hands of service from the loss of membership in other areas and leave a legacy of service for a new community, add a satellite to your current club to add members and help with service, and sponsor a new member for membership and service in your club. More hands mean more service.

First Lady Becky and I thank you for your donations and applications for grants on Pediatric Trauma through the Ohio District Kiwanis Foundation. More information and grant applications may be found at www.odkf.org. Also,

join us for the district golf outing that benefits the foundation on July 15th and 16th in Canton, Ohio

Ohio District Kiwanis Foundation Notice of Annual Meeting

The Annual Meeting of the Ohio District Kiwanis Foundation will be Saturday, August 15, 2009, at 8:30 a.m. at the Crowne Plaza Dayton, 33 E. Fifth Street, Dayton, Ohio 45402. All members of Ohio Kiwanis Clubs are voting members of the Foundation and are encouraged to be present to hear reports of the work of the Foundation, honor supporters of the Foundation, vote on changes to the Bylaws and elect new members of the Board.

District Dues Adjustment Proposal

At the District Convention in August, delegates will be asked to approve an increase in our district dues in the amount of \$8.00 per year. Some facts that you need to know about this increase are:

1. The last dues increase was approved in 1997
2. Since that time, membership declined 30%
3. Our district's reserves will be depleted in 2009
4. We have insufficient income to maintain services

The dues committee after an in-depth study concluded that a dues increase is necessary. Following that study, your district leadership took action to reduce expenditures.

Some of those actions included:

1. The district office was relocated to a smaller more efficient space
2. The District Board enacted "bare bones" budget amounting to a 20% reduction
3. Our Staff Assistant's hours were reduced

In determining the amount of the increase certain assumptions were made:

1. Inflation increasing at a rate of 2%
2. Loss in membership no greater than 2%
3. The District's return on investment shows improvement

We are often asked about what services are provided by the district office. A few of those services are:

1. Support of Officers, Board and Service Leadership Programs
2. Support for membership activities
3. Office and financial management
4. District Secretary is the Legal Statutory Agent for our corporations

Another question we are asked is how our district's dues compare to other Kiwanis districts. Briefly, we have the lowest dues among ten largest districts throughout Kiwanis International. Ohio is number five in the number of members. In a couple of cases, our dues of \$18.00 are less than 50% of what others pay.

We are asking that you support this dues adjustment so we can continue to provide services to our membership and continue to be a leader in providing service to our communities.

Simplifying Dues

Despite a time of global economic difficulties, planning and stewardship have positioned Kiwanis International in a strong financial condition. To help ensure that continues, the Kiwanis International Board is proposing Bylaws amendments that aim to simplify the dues-collection process and sustain financial stability.

A special task force of Kiwanis members studied Kiwanis International's revenue sources for the past year with a goal to provide the necessary flexibility to address changing needs while maintaining accountability to clubs and members. The International Board considered the group's recommendations and will forward four suggestions as proposed Bylaws amendments to the House of Delegates at the 2009 International Convention in Nashville, June 25-28. A fifth recommendation does not require Bylaws changes. The proposals include:

Develop an online billing system for annual club fees and new-member enrollments integrated with Kiwanis International's member database. Members would be able to update their own information 24/7, and club secretaries can process rosters and pay fees online, all via secure methods, though they would still have the option to mail paper copies if preferred. This aspect is key to the proposals, but does not require a Bylaws change to implement.

Establish a common annual billing cycle of October 1 to September 30. This would simplify the process by eliminating the confusion of staggered payment dates based

The school also provides financial support to those children who attend school beyond the 6th grade. Mission Teams go 6 times a year to assist with construction, dentistry, education in English, computers and sewing skills.

on when each club organized.

Replace the word "dues" with "annual club fee" when it relates to what clubs pay to Kiwanis International. Members owe "dues" only to their clubs, while clubs pay an "annual club fee" to Kiwanis International.

Replace the current flat "new-member add fee" with a "graduated enrollment fee" schedule that decreases each month from a starting point of \$62 (the same amount currently charged for membership dues, magazine subscription, and liability insurance combined) down to \$6 at the end of the year.

Eliminate individual magazine fee waivers for spouses. Even though Kiwanis credits clubs \$8 for each waiver, Kiwanis still pays \$5 for each magazine not mailed in fixed costs that cannot be waived (staffing, article purchases, etc.) Members who do not receive benefit of this waiver absorb the costs.

These recommendations are designed to streamline and modernize the dues and fees collection process, use technology more efficiently for members and staff, and simplify club reporting requirements, making the jobs of club secretary and treasurer easier.

Real World-Real Money comes to Akron

Kiwanis Club of Akron members Barb Snyder, Kurt Winebrenner, Christy Ramsey, Ron Mitchell, Olivia Wakeling, Ron Ferre, Katie Rennard, Laura Brelin, Phil Stauffer, and Kara Hanzie joined Kwianians all around the world for Kiwanis One Day on Saturday, April 4th at the Boys & Girls Club of the Western Reserve. Club Kids and Kiwanians participated in an inter-active, educational program.

Real Money, Real World is an active, hands-on experience that gives young people the opportunity to make lifestyle and budget choices similar to those they will make as adults. Throughout the duration of the program, students assume the role of a 25-year-old adult who is the sole income provider for a family. They receive an occupation, monthly salary, and the number of children they are raising. Students learn to subtract savings, taxes, and health insurance amounts from their income. The amount of money left over is what they have to spend during the simulation activity. Kiwanis members represented actual businesses in the community; setting up and staffing booths representing real-life businesses and assuming the roles of Real Estate agents, Grocery Store Owners, Landlords, Car Salesmen, Child Care Providers and Financial Planners. By visiting the appropriate booths, students spend their salaries on items typically found in a monthly budget including housing, utilities, groceries, insurance, childcare, and transportation. Afterward, students reflected on their experience and what they learned.

Co-Chair Olivia Wakeling staffed the charitable contributions table and encouraged the children to think about supporting the organizations that they were passionate about, like the Boys & Girls Club.

Katie Rennard had the "Chance" table where the kids learned that life is full of unexpected happenings, both good and bad. The children developed valuable skills including how to write a check, balance a check book and set a budget to live within their means. Overall the event was very enlightening and highly educational for the students.

KIWANIS INTERNATIONAL PURSUING SECOND WORLDWIDE SERVICE PROJECT

NASHVILLE, Tenn. (June 27, 2009) – Kiwanis International, in 1994, made a pledge to help protect children from the scourges of Iodine Deficiency Disorders in its first Worldwide Service Project. Now, with the majority of the world's children protected against IDD, Kiwanis is inviting organizations, institutions and individuals to propose a project to become the global service organization's second worldwide service initiative.

"We live today in a world of need," said Kiwanis International President Don Canaday, of Fishers, Ind. "People suffer debilitating and deadly diseases that need treatment or cure. Children live in poverty and go hungry, absent access to education, help and hope.

"Today more than ever Kiwanis is needed to help ensure that families and children have food, clean water, a safe and secure shelter," said Canaday.

Solutions, Canaday added, will require many hands, many nations, many years, but small differences can set in motion a cascade of significant change. "One hand outstretched becomes two becomes four, becomes eight. Borders, boundaries and cultures are crossed and change becomes a cause, a commitment and, eventually, a cure," said Canaday.

In 1994, Kiwanis committed to help protect children against IDD, the leading preventable cause of lifelong mental and physical disabilities. Today, the organization, with its 8,000 clubs in 70 nations and geographic areas, is taking the next step in its journey to change the world for children and communities—Kiwanis is asking its members and others to propose its next Worldwide Service Project.

"Kiwanis has achieved its goal to virtually eradicate Iodine Deficiency Disorders," said Rob Parker, CEO of Kiwanis International. "Today, our partner in that effort, UNICEF (United Nations Children's Fund) estimates the number of households consuming iodized salt has jumped from 20 percent in 1990 to more than 70 percent today.

"There remain a few pockets of need and we will remain vigilant to keep moving that needle upward, but it's time now to begin to identify the next Worldwide Service Project where the helping hands of Kiwanis can help improve the life of children and communities," said Parker.

Kiwanis' Worldwide Service Project is a directed program that engages all of its youth and adult members to make a positive difference in the world by helping children in need.

Proposals, due by Oct. 1, 2009, are invited from members, organizations, agencies and institutions. Project criteria include:

- Involve a child-focused issue or problem
- Be compelling and relevant
- Involve both a global and a local level of participation and impact
- Include hands-on service and fundraising
- Address a virtually solvable problem or issue
- Support Kiwanis membership growth
- Lead to life-changing experiences

- Describe your project and how it matches the criteria (500 words or less)
- How does the project align with Kiwanis' mission? (200 words or less)

Kiwanis will accept nominations until Oct. 1, 2009, and will announce its second Worldwide Service Project in June 2010 at the organization's 95th annual convention in Las Vegas.

Avon Lake Kiwanis uses “Kiwanis One Day” to help hundreds of Uganda’s Children

The Day was April 8, 2009. Our Kickstart Moneymaker pump arrived at Buhoma Primary School in Uganda to extend garden productivity and feed 400 children—not for a day, but every day. A one time cost of \$200 dollars works this miracle.

We’ve all heard the sad stories of disease, dictatorship, and drought. We know children in Africa are hungry, but how to help with problems of this magnitude with limited resources? “We think we have found a viable means by purchasing from the Kickstart organization”, says Pam Hoffmann, the Service Chairman for the Avon Lake club. But let’s start from the beginning.

With four growing seasons in Uganda and many other parts of Africa, the problem for food productivity is **water** for gardens during drought. Buhoma School garden is 22 feet from a creek which is a constant source of water, but there is no easy means to get the water up the hill to the plants.”

Enter Martin Fisher a mechanical engineer from Stanford and the founder of **Kickstart**. His goal is to end poverty in Sub-Saharan Africa—the poorest place on earth. Kickstart works to remove the root cause of poverty, lack of income, rather than focus on social services to alleviate the effects of poverty.

This is the type of service Avon Lake Kiwanis wants to be involved with. “With \$200 we can feed 400 students for a day, but the same money invested in a pump, allows the school to feed the children indefinitely” says Hoffmann. What a value with tremendous return.

Kickstart’s (www.kickstart.org) manual pump is transforming lives. Their efforts are well recognized. In 2003 Newsweek Magazine designated the **moneymaker pump** as one of **10 inventions that will change the world**. “This is no ordinary pump. It looks much like a stripped down step aerobic machine”, says Hoffmann. “It requires no electricity, and allows people to lift water up to 46 feet from a stream or river. Rural Africa has no electricity (pumps we use would be of no use). They have no sophisticated tools so repair of a c o m p l i c a t e d machine would be impossible”.



Much of Sub-Saharan Africa has only one growing season without irrigation. They have water in the dry seasons, just



no easy way to get it up hill to the garden/field. With this micro-irrigation device the average farmer no longer has to carry buckets of water. With adequate

water he increases his yield and makes over \$1000 profit per year, increases his net farm income 10 fold, and recovers the investment in 3 months (Kickstart statistics).

As of April, 2009 with the delivery of the Kickstart pump funded by Avon Lake Kiwanis, the children of Buhoma will no longer have to carry water or watch their food source wilt and die. The school will have water for the garden year around which will increase their yield dramatically.



The Kiwanis mission is to “change the world, one child and one community at a time”. Avon Lake Kiwanis is proud to use Kickstart’s innovation to live up to our mission,” says Hoffmann. Our Club purchased the Uganda pump for \$160 but wiring money to Kampala cost \$44 for a total of \$204.

This cost is within any club’s reach and we encourage participation by as many Ohio District Kiwanis Clubs as possible. By working within the Kiwanis organization we are able to be in contact with the people we help. We like it!
